What information we collect, use, and why

The types of personal information we obtain about you depends on how you interact with our site and use our services. The following sections describe the categories and specific types of personal information we collect. We may collect information by message through our contact form or when you subscribe to our newsletter or weekly email marketing. We may communicate or contact you by email, text message, messenger, phone number or address

We collect or use the following information to **provide services and goods, including delivery**:

- · Photographs or video recordings
- · Records of meetings and decisions

We collect or use the following information for the operation of customer accounts and guarantees:

- · Purchase history
- · Marketing preferences

We collect or use the following information for service updates or marketing purposes:

We collect or use the following personal information for dealing with queries, complaints or claims:

- · Payment details
- · Account information
- · Purchase or service history

Lawful bases and data protection rights

Depending on where you live, you may have some or all of the rights listed below in relation to your personal information. However, these rights are not absolute, may apply only in certain circumstances and, in certain cases, we may decline your request as permitted by law.

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO's website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO's website:

- · Your right of access You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for.
- · Your right to rectification You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete.
- · Your right to erasure You have the right to ask us to delete your personal information.
- · Your right to restriction of processing You have the right to ask us to limit how we can use your personal information.
- · Your right to object to processing You have the right to object to the processing of your personal data.
- · Your right to data portability You have the right to ask that we transfer the personal information you gave us to another organisation, or to you.
- · Your right to withdraw consent When we use consent as our lawful basis you have the right to withdraw your consent at any time.

· Managing Communication Preferences – If you subscribe to our communication services for weekly, monthly updates or promotions of whats available and you wish to opt out of receiving these at any time. Please contact us and we will remove you from our email, messaging contact. We may still send you non promotional emails or messages, such as those about your account or orders that you have made.

We will not discriminate against you for exercising any of these rights. We may need to collect information from you to verify your identity, such as your email address or account information, before providing a substantive response to the request. In accordance with applicable laws, you may designate an authorised agent to make requests on your behalf to exercise your rights. Before accepting such a request from an agent, we will require that the agent provide proof you have authorised them to act on your behalf, and we may need you to verify your identity directly with us. If you make a request, we will respond to you in a timely manner as required under applicable law.
