Use of the Website

This website is operated by The Twiggery. Throughout the site, the terms "we", "us" and "our" refer to The Twiggery. The term "site" means the website located at www.thetwiggery.co.uk. The Twiggery offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site/Website/making contact or ordering from us, you engage in our "service" and agree to be bound by the following Terms and Conditions. These Terms and Conditions apply to all users of the site, including without limitation users who are browsers, customers, merchants, and/or contributors of content.

Our data records are part of our business. Booking Flowers with us

Full payment is required to secure the flowers or services of The Twiggery for your booking, wholesale order/wedding or event date. You are responsible for checking the day, month and year of your booking and that they are correct.

We are unable to hold any date or make a booking until payment has been made and received by us.

Making a change to booking/order

If you wish to make a change to your booking/order we are more than happy to make any alterations but would require full payment for any changes before we could agree to the alteration. We are unable to make any changes to your order 14 days before the booking/event date.

Cancelling an order

If you wish to cancel an order we will require written confirmation 14 days before the event/collection date for flowers for a full refund. If it's within 14 days of the event/collection date The Twiggery will retain 50% of the original booking price of the flowers.

Collection, and or delivery of Flowers

If you have any queries regarding the condition of the flowers, these need to be raised with The Twiggery at the time of collection or delivery. We are unable to rectify any queries once the flowers have been accepted by you. We do not currently offer a delivery service. Flowers will be available for collection only from us.

Condition of flowers

We cut your flowers in the coolest part of the day and condition your flowers as close to your chosen date/order/event day as possible, this is to ensure that your flowers are as fresh as possible. If you require your flowers earlier than we agree acceptable for the best condition of your flowers, we are unable to guarantee the condition of your flowers on your chosen date/order/event day.

Can I choose a specific flower type

This may be something we can offer but this all depends on whats in season on your chosen date. All buckets are mixed and to growers choice, as to whats in season and are all dependent on the weather. We can not guarantee a specific flower and we reserve the right to use a substitution that we deem suitable.

Do you offer help on site or at the venue

We only grow and supply the flowers. If you require help with placement or setting up, we would advise that you speak to the site or venue you are using. They may offer this service.

What happens if something goes wrong with the flowers

We pride ourselves in offering quality flowers. However there maybe an incidence out of our control, for example, adverse weather or insect attack. Please be assured that we have access to other British Growers and suppliers of British Flowers should the worse happen.

For each bucket of flowers we charge £5.00 for the bucket which is payable by you when you order your flowers. If you do not wish to pay this charge, you will need to bring your own buckets with you when you collect your flowers. We are however happy to refund you for any buckets charged for that are returned to us after the event. Please make sure you contact us before you return any to us.

Please note that some flowers and plants may be harmful or poisonous

In particular, Foxgloves which are poisonous and toxic if eaten, Lilies which can be extremely toxic to cats and Agrostemma Corn Cockle is toxic to Chickens and can cause loss of ewes in Sheep.
